



Car Rental Terms and Conditions

Thank you for redeeming for an Enterprise Rent-A-Car gift certificate. Please follow the instructions below to insure that your valuable reward becomes a rewarding experience.

- 1) Contact the Enterprise Rent-A-Car national reservations office by dialing toll-free 1-866-875-0459.
- 2) Mention the code AMXMRP (a.k.a. customer code) to the agent when making your reservation or inquiry and be prepared to provide the unique certificate # shown at the bottom of this document.
- 3) The face value of the certificate is applicable only towards the base amount of the rental charges often referred to as the Time and Mileage portion of the rental.
 - a. All additional taxes, surcharges or other fees such as those added by federal or local government agencies at the time of rental will be the responsibility of the renter.
- 4) Present this original certificate at the time of rental.
 - a. Certificate can only be used once and has no cash value, meaning no credit or cash back will be given against the unused portion of the certificate.

Please note below and on the back of this certificate certain terms and conditions that may apply.

- Applicable to standard daily and weekly rates only as quoted by agents when reserving at 1-866-875-0459.
- Valid at all U.S. and Canadian locations and participating locations in the United Kingdom.
- For non-U.S. rentals, the U.S. Dollar amount stated above will be converted into local currency and applied when you surrender the certificate at the time and place of rental.
- Normal rental qualifications apply.

- Avis and Enterprise Certificates are combinable for an unlimited number of certificates on a single transaction. Hertz Certificates are combinable with up to three certificates on a single transaction.
- Car Rental Certificates may not be combined with any other corporate discount program number, discount or promotional rates or programs.
- Taxes, tax reimbursement, local airport fees, customer facility fees (\$10/contract in CA for Avis), concession recovery fees, surcharges and optional services such as refueling, upgrades to higher car classes, extra-day and drop charges, additional driver fee, LDW and optional insurance like PAE, PAI, PEC, SLL and LIS are the responsibility of the CM for Avis and Enterprise Certificates only.
- The American Express Car Rental Loss and Damage Insurance will apply to eligible rentals by eligible CMs only. Noneligible CMs and nonCMs who use Car Rental Certificates will not be covered. Payment must be made with the American Express Card.
- Renter must meet participating rental car establishment's standard driver, credit and age qualifications (minimum rental age for Hertz and Avis is 25; exceptions apply/under 25 surcharge may apply) at time and place of rental. For Hertz International rentals, driver must present a valid driver's license held for at least one year prior to rental.
- All rentals are subject to availability and require a 24-hour advance reservation. International rentals with Hertz must be reserved at least eight hours prior to departure from the U.S.
- Vehicles must be returned to renting location except where intercity and intracity drop-offs are permitted by the car rental company.
- Certificates are redeemable for the amount indicated on the face of the Certificate and have no cash value. When renting internationally, the value of Hertz and Enterprise Certificates will be exchanged into local currency at the time of rental. No credit will be issued for any unused portion. Certificates for Hertz International rentals apply to non-prepaid Affordable rates and require a minimum rental of five days and a maximum rental of three weeks.
- Certificates must be surrendered at the time of rental, and no reproductions or photocopies of Certificates will be honored.
- Renters using Certificates will not earn frequent traveler miles/credits or points.
- Car rental Certificates cannot be returned for a credit on your American Express Card or for a redeposit of points into your Program Account.
- Certificates are transferable.
